Bill asked for a moment of silence in memory of Plan Committee member Randy Callsion. Bill noted that Randy attended meetings regularly and fought hard to protect the environment around the neighborhood he loved living in.

Mr. Rick Heine, Chief of the Sullivan EMS, wanted to say Thank You to our residents for the continued support of the Sullivan EMS. He noted that they began transporting on November of 2004 with 24 calls and in 2007, they responded to 233 calls. They now have 2 ambulances and have upgraded their service to an IV Tech level and are now also able to provide Interfacility Transfer Service. Their newest venture is to provide CPR and/or First Aid training not only for their EMT's but to community members.

Lloyd Zastrow, Clerk, read the minutes from the January 14, 2008 board meeting; the Board approved a Stair/Janguart motion to accept the minutes as read.

The Board approved a Ingersoll/Stair motion to grant the request from John & Susan Strese for a lot size change from 4 acres to 3 acres.

Bill also said that last Sunday morning the two trucks plowing our roads broke down but they were able to get two more trucks out here to finish but they asked us if we could help out with our two trucks. Bill called Jack Web and Jack Kramer and they both showed up to plow – our "Thanks" to those two guys for coming out on such short notice and on such a bitter windy Sunday morning.

Dennis said that the Oskosh has been sold for \$2500.00; the plows are still available for sale.

The Board approved a Stair/Janquart motion to approve the modification of section 11.04(f)5 A-1 Exclusive Agricultural portion of the Jefferson County Zoning Ordinance. This modification would increase the maximum acreage for farm consolidation land splits from three to five acres as long as 35 contiguous acres remain in place.
